Close coverage of UHAL, as of today's close, with shares trading roughly inline with our fair value estimate

- For context, shares have appreciated ~49.5% (outperforming the S&P 500 and Russell 2000 Indexes by ~6% and ~23.5%, respectively) since our most recent recommendation in May 2022.
- While we continue to think U-Haul (formerly Amerco) is a high-quality operator in space where it has durable competitive advantages with shares trading roughly in line with our \$76.50 per share fair value estimate (with bull and bear cases of \$90-\$62 per share) we prefer to maintain a disciplined approach and close coverage/withdraw our recommendation, as of today's close.
- We will continue to monitor shares for an opportunity to re-recommend if valuation shifts or incremental steps toward potential strategic alternatives materialize.
